General Description: Flat and fast rural course through the Skagit Valley. Boston certified, USATF # WA99012MR. Race start is on Victoria Street on the south side of Burlington Edison High School. The marathon and 1/2 marathon is run on rural roads through the Skagit Valley farmlands to the entrance of Samish Island (see course map for exact route) and finishes on Burlington Edison High School track. The course will be clearly marked, and monitors will be at all intersections. Due to course restrictions, participants must finish within 6 hours. The course closes at 2:00 pm

Directions to Start: From I-5 take exit 231, and go south (you will be on Burlington Blvd). Burlington Edison High School is about 1/3 of a mile on the right. Turn right and park in the main parking lot. Victoria Street, located to the south of the high school, is the start of both races. For race control reasons we ask that all participants park in the main high school parking lot.

Pacers: MARATHON MANIACS will pace participants that are trying to qualify for the Boston Marathon.
